Liability Waiver

By entering the SANA West Rare Breeds Show (Competition) and signing this entry as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Longeur, or Exhibitor and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Rules, Regulations and Officials of the Murieta Equestrian Center (MEC), the Horse Expo Inc., the SANA West Rare Breeds Show, and the local rules of the Competition. I agree to be bound by the Rules of the SANA West Rare Breeds Show competition. I will accept as final the decision of the Event Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the MEC, the Horse Expo Inc., the Equus Survival Trust (EST), the Akhal-Teke Association of America (ATAA), and their officials, representatives, and volunteers for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Horse Expo Inc., EST, the ATAA, and/or the competition may use or assign photographs, videos, audios, cable-casts, or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, the SANA West Rare Breed Show, Horse Expo Inc., EST, or ATAA. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of the SANA West Rare Breeds Show are governed by the laws of the State of California, and any action instituted against the SANA West Rare Breeds Show must be filed in the State of California.

SANA West Rare Breeds Show Release. Assumption of Risk, Waiver and Indemnification

This document waives important legal rights. Read it carefully before signing.

I, the below signed, AGREE in consideration for my participation in this Competition to the following:

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, exhibitor, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").

I AGREE to release MEC, Horse Expo Inc., EST, ATAA, and their officials, representatives, and volunteers and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the MEC, Horse Expo Inc., EST, ATAA, and their officials, representatives, and volunteers or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the MEC, Horse Expo Inc., EST, ATAA, and their officials, representatives, and volunteers or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the MEC, Horse Expo Inc., EST, ATAA, and their officials, representatives, and volunteers or the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.

I have acknowledge the SANA West Rare Breeds Show Rules requires protective helmets or headwear appropriate for the class shown and proper footwear and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the SANA West Rare Breeds Show strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf.

I AGREE that "MEC, Horse Expo Inc., EST, ATAA, and SANA West Rare Breeds Show" and "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.

I AGREE that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to MEC, Horse Expo Inc., EST, ATAA, and/or Competition coordinator.

I represent that I have the requisite training, coaching and abilities to safely compete in this competition.
