CHECK-IN PROCEDURES

All **SANA** exhibitors must follow check-in procedures for required event forms, rules, and stabling assignments. Please remember, NO DOGS allowed.

Entries for SANA West open February 1st and close April 1st.

BEFORE UNLOADING HORSES

Check-In: All riders participating in a clinic or show must check in on Wednesday, May 8th between 8:00 a.m. and 9:00 p.m. at the Horse Expo Show Office. During check in you will sign a Release of Liability for the Horse Expo/Murieta Equestrian Center, pick-up your entry wristbands, that will give you daily access through the exhibitor gate & your final stall assignment. This is required for anyone participating in any part of the Western States Horse Expo, even if hauling in. Failure to check in will result in your removal from events & any fees incurred unless prior arrangements have been made with Horse Expo & Murieta Equestrian Center staff.

- All horses must have current vaccinations and be in good health.
- All out-of-state horses must have a current Coggins test (1 year) and Health Certificate (30 days) for entry into California.

Once participants are checked in the Horse Expo/Murieta Equestrian Center, exhibitors must check-in with the **SANA West Show Office** in the **Rare Breeds Pavilion** (across from Arenas 9 and 10) to confirm stable assignments, display & demo assignments, clinic & workshop participation, and SANA entries/exhibitor #'s.

VOLUNTEERS for the Event

All volunteers who will be helping at the event must check in at the **SANA West Show Office** in the **Rare Breeds Pavilion** (across from Arenas 9 and 10). All volunteers must sign an **Event Liability Waiver**.

REQUIRED FORMS - Horses, Participants, & Volunteers

All participants and volunteers, grooms, handlers, etc, must follow **MEC and Horse Expo Rules, SANA West Rare Breeds Show & SANA Rules** and sign a copy of the **Event Liability Waiver**. Owners/agents must provide either a copy of each horse's registration and/or a **Statement of Eligibility** for all horses in the pavilion, demos, clinics, or competition classes. These forms must be submitted with your show/clinic **Entry Form**.
